Times have changed in Head Start, especially for data sharing and maintaining privacy for child records. What was allowable before will likely not pass muster under the new Head Start Performance Standards.

45 CFR § 1302.101(b)(4) requires that all HS/EHS programs implement program-wide coordinated approaches to the management of program data to support effectively the availability, usability, integrity, and security of data. These procedures are required to be in place by **August 1, 2017**.

Zoë Beckerman Consulting, LLC, in collaboration with the **Massachusetts Head Start Association**, has developed a comprehensive set of sample procedures and accompanying forms on sharing data and protecting privacy of child records. The carefully drafted set of sample documents includes:

The detailed sample procedures that we have developed meet the requirements of the Head Start Act and new Program Performance Standards. The package of detailed sample procedures and forms is intended for HS/EHS programs across the country, except school districts or universities which must follow other rules. (The procedures and forms we have developed do not include procedures on ensuring the quality of data and effective use of data; your program will have to develop those on your own.)
